Permit applications and payments must be submitted to the City of Nampa Building Department at least 24 hours prior to the need for the first inspection. Any person who commences any work on a electrical, gas, mechanical or plumbing system before obtaining the necessary permits shall be subject to a special investigation. A special investigation fee, in addition to the permit fee, shall be collected whether or not a permit is then or subsequently issued. The investigation fee shall be equal to the amount of the permit fee required. Inspection requests must be made at least 24 hours prior to the need for the inspection. Inspection requests missing any of the required information cannot be processed. Access to the property is the responsibility of the permit
